1. Opening. The meeting was opened by RB.

2. Announcements

CG asks if the MSG can work on a contract for transparency. DH states that it is not required by law for the companies to do so. The companies do it voluntarily. We could draw up the contracts without obligation for the extractive industry.

RB indicates that it was laid down in the MoUs in previous years. It can also be included as a clause in the ToR.

CG proposes that it comes as a policy note from the Ministry of Natural Resources that companies should publish the information.

DH will look at the option and determine what the procedural route could be.

With regard to the IA, DH indicates that no one from BDO has made contact with her as yet. Nevertheless, she will be the vocal point from State Oil Company.

3. Adoption of the minutes

- Update inception report BDO. A mail was sent to the Ministry of Natural Resources, State Oil Company and the Ministry of Finance. The information that needs to be delivered is very important for the scoping phase. DH states that she will provide BDO with the necessary information before the next MSG meeting
- CG will coordinate with Arun Sadhoeram from BDO if they wish to receive the info with parts or rather all at once

4. Update inception report BDO

This point was taken of the agenda.

5. Budget SEITI Secretariat

The budget was adjusted after the MSG approved SEITI Secretariat's proposal for the institutions to be chosen to provide the 3 capacity building training, to know: Finance for NGO's, Writing a project proposal and Project Management.



The adjusted budget was approved by the MSG. The next step for SEITI Secretariat is to write an official sponsorship application letter to Shell in order to finalize the verbal commitment.

6. Any other business

GT announces that the EITI has been included in the IMF's program that was approved on December 22nd, 2021. This means that financial resources for EITI can also be requested within the IMF fund. While IMF will monitor SEITI's performance, they will in particular verify if MSG has completed reports in line with deadlines. That is one of the eligibility requirements for the funds. GT has given an update on the reports of 2018, 2019 and 2020 during the meetings with the IMF.

DH asks if there is some information GT is allowed to share with the MSG. GT states that she will share the report regarding the measurements with the MSG. Please find below the link that GT has shared in the MSG appgroup:
