4. Scoping study 1st EITI report Suriname

After extensive discussion if the 1st EITI report should include the year 2015, it is decided in MSG that 2015 should be a narrative in the 1st EITI report due to:

- De government (tax office) had a transformation in 2015 in their system which will make it difficult to trace back the data given the limited time the IA has;
- The Ministry of Natural Resources has another system for requesting concession rights, and these documents cannot be trace back.
- A narrative for the bauxite sector also should be mentioned in 2015.

For the year 2016 reconciliation must take conducted for the 1st EITI report by IA. BDO is in process doing the Scoping Study for this report.

5. Ranking Communication Firm Specialist

The SEITI Secretariat with 2 workers of the Ministry Natural Resources made a matrix for the Plan of Action and the requirement of the interest Companies. The outcomes are that Minves, Agape Wings and O' Media are the top 3 ranked for this position. The proposal is that these companies present their plan of Action later this month. The proposed presentation date is 14 June 2018 and from each constituency at least one member will be present.
